



**MESA JUNIORS VOLLEYBALL COMPANY 2020-2021 SEASON
ASSUMPTION OF THE RISK AND WAIVER OF LIABILITY RELATING TO
CORONAVIRUS/COVID-19**

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely dangerous and is believed to be spread from person-to-person contact. As a result, federal, state and local governments and health agencies recommend established guidelines to reduce the risk of spreading the virus. These include requiring social distancing and, in many locations, prohibiting the congregation of large groups of people. These guidelines are for the safety of the public and should be followed. Notwithstanding recommendations and guidelines by these entities, it must be understood that that COVID-19 is a continuing threat to the health and lives of the citizens of Colorado.

Mesa Juniors Volleyball Company has put in place preventative measures to reduce the spread of COVID-19. However, it is understood that Mesa Juniors Volleyball Company cannot guarantee that you or your child(ren) will not come into contact with or become infected with coronavirus. Your mere physical presence at the Mesa Juniors Volleyball Company activities could increase your risk and your child(ren)'s risk of contracting the disease.

Notwithstanding the risk of infection, I, on behalf of myself and my minor child(ren), wish to voluntarily participate in volleyball activities offered by Mesa Juniors Volleyball Company. These include practices and other training, volleyball matches, team activities and possibly travel to other facilities not under the control of the Mesa Juniors Volleyball Company for volleyball matches.

In consideration of being allowed to participate in any way in Mesa Juniors Volleyball Company programs, and related events and activities, I, and/or the minor child(ren) state as follows:

1. I understand that although Mesa Juniors Volleyball Company has taken precautions to provide proper organization, supervision, instruction and equipment for the services being offered, it is impossible for Mesa Juniors Volleyball Company to guarantee absolute safety from infection by the coronavirus. Also, I understand that I share the responsibility for safety during all activities, and I assume that responsibility. I will make my instructors aware to the best of my ability of any questions or concerns regarding my understanding of safety standards, guidelines, procedures and my ability to participate at any point during any activity. I will also take steps to ensure the health of my child(ren) before the child participates in any volleyball activity.
2. I understand that risks during volleyball activities include possible exposure to the coronavirus.
3. I assume all the foregoing risks and accept personal responsibility for the damages due to such injury, permanent disability or death resulting from participation in any Mesa Juniors Volleyball Company activity.

If you are the parent or legal guardian of a student, please read this document to the child(ren), and if you both agree and understand their content, place YOUR signature in the appropriate places.

I voluntarily agree to assume all of the foregoing risks described in this waiver and accept sole responsibility for any injury to my child(ren) and myself (including, but not limited to, personal injury, disability or death), illness, damage, monetary loss, claim, liability, or expense of any kind, that I or my child(ren) may experience or incur in connection with my child(ren)'s participation with Mesa Juniors Volleyball Company or Mesa Juniors Volleyball Company activities ("Claims"). On my behalf, and on behalf of my child(ren), I hereby release Mesa Juniors Volleyball Company, its agents, coaches, chaperones, board of directors, and employees from any and all claims, demands, and causes of action, whether resulting from negligence or otherwise, of every nature and in conjunction with a Mesa Juniors Volleyball Company activity as set forth of this waiver.

In addition, by signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that my child(ren) and/or I may be exposed to or infected by COVID-19 by attending Mesa Juniors Volleyball Company activities. I understand and agree that this release includes any claims based on the actions, omissions, or negligence of Mesa Juniors Volleyball Company, its employees, agents, and representatives, whether a COVID-19 infection occurs before, during or after attendance at Mesa Juniors Volleyball Company activities.
