



PLAYER – PARENT CODE OF CONDUCT CONTRACT

This contract must be signed by the player and the player’s parent/guardian and returned to the Mesa Juniors Volleyball Company before such player is permitted to participate in any Mesa Juniors Volleyball Company activity (except tryouts).

Players and parents represent the Mesa Juniors Volleyball Company and therefore will be held to the standards set forth in the club handbook. Any circumstance that, in the judgment of the Mesa Juniors Volleyball Company Board of Directors, adversely affects the player’s ability to serve as a positive representative and role model for the club may be deemed a violation of the standards set forth in the Mesa Juniors Volleyball Company Handbook and will result in disciplinary action as outlined in the handbook and may be subject to suspension or dismissal from the Mesa Juniors Volleyball Company.

In consideration for the privilege of participation in the Mesa Juniors Volleyball Company, I, the undersigned player agree as follows:

- I have read and reviewed the complete copy of the Mesa Juniors Volleyball Company Player-Parent Handbook and agree to comply with the Mesa Juniors Volleyball Company and USAV training rules, behaviors, policies, guidelines and expectations stated therein.
- I understand and agree that the training rules, behaviors, policies, guidelines and expectations shall be in full force and effect 24 hours per day, seven days per week, 365 days per year from the date this contract is signed, including and outside of Mesa Juniors Volleyball Company activities.
- I understand that my privilege to participate as a member of Mesa Juniors Volleyball Company may be suspended or revoked in accordance with the three strike policy in the event the Board of Directors determines that I have violated or otherwise failed to comply with the training rules, behaviors, policies, guidelines and expectations at any time following the date this Code of Conduct Contract is signed by me and my parent/guardian.
